- 1) A signed letter stating your intellectual interests, your activities and employment (if any), and the real estate career you expect to follow. (This statement shall not exceed 1,000 words in length and should be typed in as simple and concise manner as possible.)
- 2) A statement of proposed program of study signed by the Dean or Faculty Advisor or an authorized official of the College or University in which your study is to be completed. Include a brief description of the courses taken or planned in order to pursue the degree named on application.
- 3) Official copies of transcripts of all your University course records certified by the Registrar or other authorized official.
- 4) Letters of recommendation from two persons. It is preferred, but not required, that one of these letters be from a REALTOR® or SIOR. *Recommendations are to be emailed or faxed directly to Brad Coven, SIOR and kept confidential, and under no circumstances to be revealed to the applicant.*
- 5) A statement of financial need, if applicable.
